**Requirements** Vendors wishing to participate in the Pediatric Documentation Challenge must meet the following requirements:

- Vendors must be registered exhibitors at the AAP National Conference & Exhibition.

- Vendors must be committed to achieving certification of the EHR version being presented under the Temporary Certification Program to be established by the Office of the National Coordinator for Health Information Technology.
- A practicing pediatrician or midlevel child healthcare provider (eg, PNP, PA) *who uses the software in clinical practice* must conduct the demonstration.
- The presentation must follow the pediatric case study, which will be provided approximately 1 month prior to the event.  
*NOTE: The case will focus on the requirements of Meaningful Use, and will be designed to stretch the EHR's capacities.*
- If the moderator determines that the company spokesperson is dominating the presentation, or that the presentation is significantly deviating from the case, the moderator may interrupt in order to correct this.
- Vendor representatives and presenters must be present approximately 30 minutes prior to the assigned presentation time.
